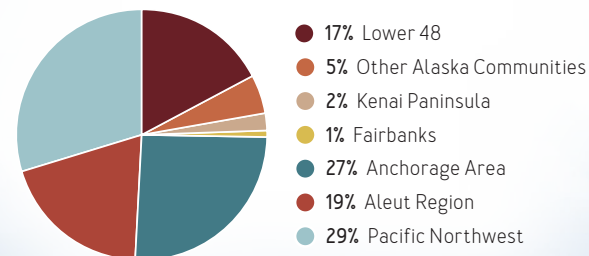

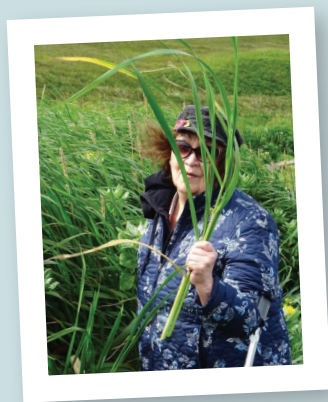

SHAREHOLDER OF THE YEAR **AGNES THOMPSON**

Agnes Thompson was born and raised in Atka, AK in 1947, right after the devastation from WWII had ripped through the Aleut community. Like

many, she attended boarding school and took college classes in Anchorage. Even for a village girl, she adapted well to the big city. She even got her pilots license and did over 100 skydiving jumps in her early twenties.

She soon met and married Harvey J. Thompson, and they raised their 6 children between Anchorage and their summer fish camp, where Agnes ran her own boat and setnet fishing permit for over 20 years. Agnes always reminisces about those being the best times of her life. She taught hard working values to her children. She has always been a devoted Russian Orthodox Christian, playing an integral part in the building of St. Innocent's Orthodox Cathedral in Anchorage, where she served as the Sisterhood Secretary for many years, working closely with Fr. Nicholas Harris and Mary Bourdukofsky. After her husband's passing in 1995, Agnes went back to college at age 53 to provide for her last two school age children.



Agnes learned basket weaving from her mother, Olean Prokopeuff, but also learned and mastered techniques under her Godmother, Jenny Golley, and her aunt, Pariscovia Wright. She always reserved time for her love of basket weaving, no matter how stressed

or crazy life got, you could often find her in her special chair, weaving peacefully among the chaos. Her passion for art, especially teaching it to anyone who shows interest, only grows over the years. She remains active in the Unangaꔁ community and teaches at several culture camps, especially trying to get to Atka every summer.

“ My preferred weaving material is the wild beach rye grass from my home village of Atka, when I can get it. It is a tall, dark, green, flexible grass which is strong and pliable. To have this particular style of grass maximizes the experience. To weave with the original, intended material is effortless and encourages your creativity.

Personally, I feel to weave is to be calm, creative, and reflective. There is nothing more satisfying than having beautiful, pliable, glossy, cured Aleutian grass and a nice selection of silk thread to encourage one to create. This is something all weavers should experience. There is something I take from weaving, both the spiritual and emotional connection to the weavers in my family before me and a physical connection when I create baskets using grass grown on the island my people have inhabited for thousands of years. It is imperative to preserve this old art tied to the Unangaꔁ people and culture.”

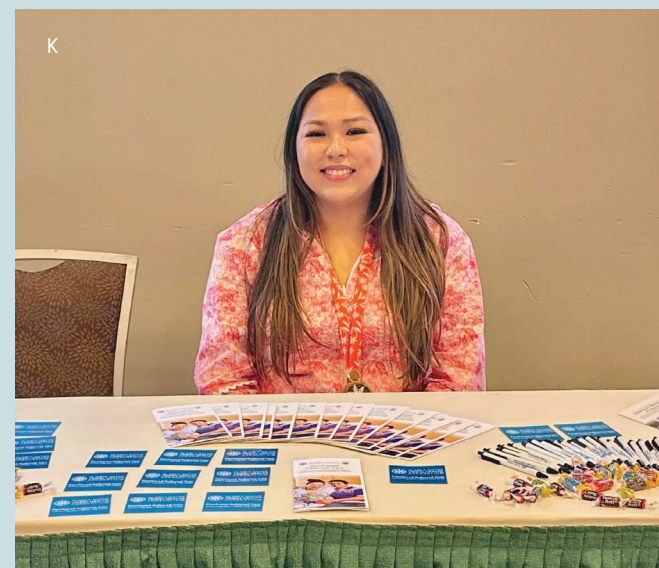
STUDENT OF THE YEAR **DANIELLE MERCULIEF**

Danielle graduated from Mt. Edgecumbe High School in May of 2015. She knew her main goal was to educate and advance her career in a tribally affiliated organization. In August of 2021 she obtained the Alaska Rural Management certificate followed by an associate degree in business administration a year later. Now, Danielle is on her way to graduating with a bachelor's degree in business management with an emphasis in Healthcare Management.

While working and attending the university, she has gained a new perspective on Indian Health Services and tribal affiliated organizations. This inspired her to get the leadership skills needed so that she may advocate for Alaska Native and American Indian people across the state.



Upon graduation, Danielle plans to pursue a master's in business administration. With her earned bachelor's degree, she wishes to further advance her career through tribal health organizations. She plans to make a difference for Alaska Native communities. Danielle is most interested in quality improvement and is excited to see what opportunities will arise with her new college degree.

In July of 2023, Danielle and her partner Chaylen Delgado welcomed their beautiful baby boy, Stefan, into the world, making them a family of three. Danielle keeps herself busy these days as she is a full-time student, a full-time student and now a full-time mother.

CHARLOTTE RUTHERFORD A CHAMPION OF UNANGAĀ COMMUNITY & CULTURE



Charlotte Rutherford, a 17-year-old senior at Service High School, is on a noteworthy journey of Unangam Tunuu

revitalization and UnangaĀ cultural celebration – all while navigating the rhythms of her bustling teenage life.

"I first did APIA's culture camp in 2017 when I was 12 years old." Charlotte recalls. It was an opportunity that would change her life.

Aleutian Pribilof Island Association's (APIA) culture camp was supposed to be only a two-week experience, but Charlotte's enthusiasm carried her through every weekday, except for Friday, for the next several weeks.

Charlotte's first internship with APIA began immediately afterwards. Over the years, she grew from a volunteer to a dedicated team member, pushing her out of her comfort zone.

Her dedication soon extended to the Anchorage UnangaĀ Dancers, a group she joined in 2017. "My language work gave me the motivation to join the Anchorage UnangaĀ Dancers," she says, adding that, "dancing in general makes me feel good; I love the drums and listening to the UnangaĀ beats."

Charlotte's commitment to Unangam Tunuu and her cultural heritage doesn't end with her own journey. She's dedicated to sharing this passion with others, bridging generations, and preserving UnangaĀ culture.

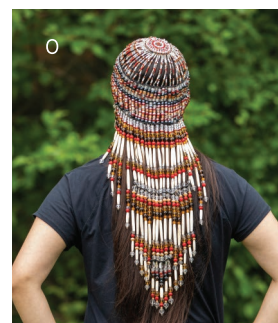
"It's amazing! I feel so very proud," Charlotte's mother Michelle adds, as she has watched her daughter's involvement in UnangaĀ dance and language revitalization grow over the years.

Michelle was inspired by her daughter's involvement and has since spent time practicing UnangaĀ traditions herself. "When Charlotte started in the dance group, there were a lot of adults there, and the dancers asked all of the parents to join. 'Why not?', I thought," Michelle says. She, too, began to participate in the UnangaĀ Dancers, volunteering to sing for the dance practices.

For Charlotte, every moment is an opportunity to learn, grow, and contribute to her community. Her achievements go beyond



cultural preservation; she won second place in a Nobel Peace Prize Poster Contest in the sixth grade, an honor she achieved while maintaining excellent grades.



Though both Charlotte and Michelle acknowledge that some of their family members from older generations still grapple with the changing cultural landscape, the impact of Charlotte's work on Unangam Tunuu revitalization is palpable within her family and community.

"It wasn't very cool or acceptable to be Native when we were growing up," Michelle reflects. "Now, some of my relatives are starting to see how special it is to get to speak and learn Unangam Tunuu and learn our culture."

For UnangaĀ youth who aspire to follow in her footsteps, Charlotte offers this advice: "Don't think about what everybody else will say or think. Teens sometimes view this as uncool, but you shouldn't think about that. Just stick with it, and eventually, you'll start to understand the meanings of words and will be able to recognize patterns, and you'll realize that you're actually learning Unangam Tunuu and you'll want to keep going!"

Charlotte's journey is a testament to the power of youth, dedication, and pride in oneself and heritage. Her commitment to preserving UnangaĀ culture and language is a source of inspiration for her community, bridging generations to ensure that Unangam Tunuu continues to thrive for years to come.

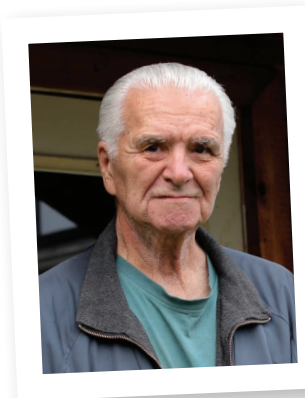

Memory Eternal to one of The Aleut Corporation's founding Board Members.

Charles Allen Hoff, a beloved son, father, and grandfather, passed away on August 30, 2023, at the age of 83 in Anchorage. He was born on

April 13, 1942, to Charles Allen Hoff Sr. and Annie Hoff of King Cove.

Charles' journey in life was marked by dedication and hard work. He graduated from Mt. Edgecumbe and attended a trade school in Texas to pursue his passion for mechanics. He returned to his Alaskan roots after graduating and for almost four decades, Charles dedicated himself to civil service, leaving a lasting impact on his community through his diligent work in the field of diesel mechanics.

In his later years, Charles followed another dream, owning and operating a successful Halibut Charter in Homer, Alaska. Beyond his professional pursuits, Charles cherished his hobbies and interests. He found solace in fishing, clam digging, hunting, and an occasional game of bingo where he enjoyed the camaraderie of friends.

After a long battle with Alzheimer's disease, a condition that he faced with courage and grace, Charles sadly passed away. Even in the face of this challenging illness, his spirit remained strong.

Charles is survived by his loving daughters Sylvia Berg and Tammy Groves, sister, Diane McRae, and brother, Clifford Hoff Sr. He was a proud grandfather to Troy Mack, Justin Mack, Kenny Bradley, and Mitchell Berg. He also leaves behind several great-grandchildren.

Charles Allen Hoff's legacy is one of hard work, determination, and a love of family and his Unangaġ heritage. He will be dearly missed by all who had the privilege of knowing him.

ILIODOR PHILEMONOF
APRIL 13, 1942 – JUNE 16, 2023

Iliodor "Ed" Philemonof, loving son, brother, father, uncle, grandfather, and friend passed away on June 16, 2023.

Iliodor was born April 13, 1942, to Isaac and Erena (Mercurief) Philemonof. He was the second oldest of six

siblings. On June 24, 1942, during World War II, when he was just two months old, he and his family were forced to leave their home and were interned at Funter Bay in southeast Alaska. It is believed Iliodor may have been one of if not the youngest individual(s) of over 800 Aleuts interned. He was two and half years old when he and his family returned to St. George.

He was raised on Saint George Island until he attended Mt. Edgecumbe Boarding School in 1957 for four years and graduated in 1961. After graduating high school, he returned home for two years to work and continue the commercial fur seal harvesting. In 1963, he moved to South Canaan, Pennsylvania to attend St. Tikhon's Orthodox Theological Seminary, which he graduated from in 1967. During the summer breaks of high school and seminary, he went back home to work at the St. George Seal Plant with the "Fur Seal Gang".

Iliodor spent his lifetime leading, working, and advocating for the Aleut People, their culture, language, and community. His leadership involvement included positions with organizations such as the Aleut League, the Aleutian Planning Commission, the Alaska Federation of Natives (AFN), St. George Tanaq Corporation, St. Innocent Cathedral, and the Aleutian Pribilof Islands Association (APIA). Iliodor shared his extensive knowledge in the Aleut community by providing guidance, support, advocacy, and mentorship. He was a dedicated linguist known for his contributions in preserving and revitalizing Unangam Tunuu (Aleut language).

He is preceded in death by his brother Father Paul Mercurief and sisters, Edna Floyd, and Irene Melovidov. He is survived by siblings, Dimitri Philemonof and Maria Stowe. He leaves behind three children, Iliodor Philemonof II, Isaac Philemonof, and Alexis Philemonof. He will be missed by his six grandchildren, Iliodor III, Lindsey, Treyccen, Rhylynn, Gracelyn, and Ashlynn.

May he be remembered for his passion and dedication to preserving the Aleut Culture and enhancing the lives of the Aleut people.



ILENE EVANS
July 28, 1942 – May 12, 2023

Ilene was born in Portland, OR after her Unangaġ (Aleut) family was removed from their home in the Aleutian Islands when Japan invaded during WWII. She was a member of the Qagan Tayagungin tribe, and shareholder of Shumagin and The Aleut Corporation.

Ilene was the daughter of James Leroy Evans and Lily Osterback and sister to Lea, Julie, and Connie. She lived in Oregon, California, and Walla Walla, WA before her family settled in Green Lake, WA. Ilene graduated from Lincoln High in 1960 and, later, from the University of Puget Sound (in 1978) with 2 bachelor's degrees, in Art and Sociology.

Ilene was a prolific artist and writer and kept daily notes and sketches and self-published several books. She was an activist and advocate for Indian fishing rights in the Pacific Northwest in the early 1970's. She ran in 5K's and won her first 1st Place finish at the age of 69. She was active in the Pacific Northwest Aleut Council for many years. Ilene enjoyed genealogy sleuthing and family history research trips. Ilene suffered 2 traumatic brain injuries, in 1985 and 1999. Those events left her physically and cognitively disabled, but she stayed active and busy and fiercely independent. She could be seen walking or bussing around her beloved downtown Seattle almost every day. Ilene was an animal lover, caring for many cats and birds, her bunny, Spot, and her beloved dog, Chena.

Ilene is survived by her daughter, Gina M. Gerking Spiller, son Allan L. Gerking (Cheryl), her grandchildren, Leslie Gerking (Anthony Lewis), Haley Gerking Mendoza (Sergio), Kallin Ann Spiller, Justin C. Spiller, Amanda Williams Carpenter (Cam), Ashley Williams Simpson (Charlie), and great grandchildren, Charlotte Mendoza, and Ezekiel Lewis.

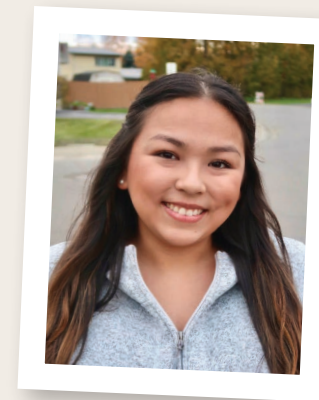

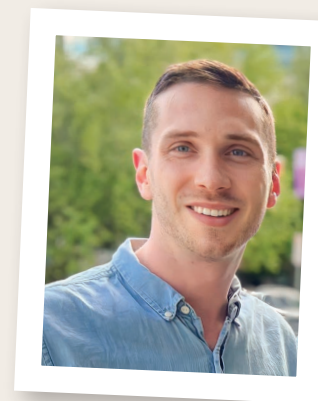
