It is my pleasure to formally welcome Danny Parrish as our new Chief Financial Officer (CFO). Danny joined the Aleut team in November 2023 and has already made a meaningful impact. His experience, insights, and financial acumen are guiding our financial strategies and policies as we prepare to close out this fiscal year.

In January, TAC Management presented our strategic vision to the Board for next fiscal year (FY25 starting April 1). Navigating challenges, celebrating successes, and embracing growth have been hallmarks of our recent journey. We have made incredible strides over the last few years to stabilize operations, streamline processes, and hire the right people to help us grow. Part of that assessment was divesting of businesses that were not meeting our financial goals. ARTIST SPOTLIGHT

CHIʔTAʔ DESIGNS

BRIDGING ART, COMMUNITY, AND ACTIVISM



For Mercedes Laadakuchaʔ (Little Doll) Kashatok, art is more than individual expression; it's a powerful tool for community building. As Mercedes describes it, the acts of creating and sharing are inherently communal experiences that create the space necessary for healing dialogues, connection, and understanding.

“ Art is a great tool. It brings people together and helps build a capacity to be present and open important dialogues with yourself and your community.”

Mercedes' artistic journey began as a child when, as a participant of APIA's Urban Unangaʔ Culture Camp, they crafted their first headdress while surrounded by friends. “Beading and sewing didn't come naturally for me,” they shared, before adding with a smile, “but the love I have for these art forms did! I just thought, ‘this is so cool! I'm having so much fun!’”

Reflecting on that experience, Mercedes remarked, “Even though it took me almost three months to finish that first headdress, finally seeing it come together was really gratifying—it made all the pricked fingers and Band-Aids worth it.”

Chiʔtaʔ Designs, Mercedes' business identity, draws its name from the Unangam Tunuu word for rain. Mercedes explained, “The name ‘Chiʔtaʔ’ came from when I was a kid at culture camp and we were choosing our Unangam Tunuu names. All the other kids were choosing names that meant flower, or different pretty colors – I looked outside to the pouring rain, and asked, ‘What's the Unangam Tunuu for rain?’ Chiʔtaʔ! I held onto that name for a while so when I opened my business, Chiʔtaʔ Designs felt right – that name just fell into place.”

Operating as Chiʔtaʔ Designs, Mercedes sells their handmade earrings, necklaces, qaspeqs and other wearable garments, as well as stickers and other art prints. Mercedes' art isn't limited to what you see shared on their website though: “I like to try things here and there just to see how fun it can be,” they revealed. And that playful approach to art has extended Mercedes' work to several forms, including drawing, painting, and crocheting, some of which you can view via their Instagram page linked below.

In their time creating and sharing art, Mercedes has found both inspiration and camaraderie in the vibrant Indigenous art community on social media. Reflecting on the evolving landscape for Indigenous artists, Mercedes called attention to a significant shift in the role of social media over the past five years, noting, “Now there are so many new Indigenous content creators, actors, actresses, and models, and we finally have respectful representations of who we are in



mainstream media. Now kids get to grow up seeing people who look like them and understand what it's like to be Indigenous in the world right now—it feels very special.”

Mercedes remarked on the increased visibility and respect for Indigenous artists they have observed in mainstream media, noting that, “it's common now to go up to someone and say, ‘Oh my gosh, I love your earrings! Who made them?’ and being able to share Indigenous-made art day-to-day helps us embrace our culture, it normalizes our visibility—we have always been here, and we have always deserved respect!”

Collaboration and community are both recurring themes throughout Mercedes' journey as an artist. Their holistic approach embodies a philosophy of self-expression that prioritizes sharing for the sake of connection, not for recognition.

Mercedes urges creatives to steer clear of doubt and comparison, recognizing that such hindrances can impede the drive to create and share. “As long as you're creating for yourself and respecting those around you, you can't go wrong—you're already an artist, you have it in you! It doesn't matter if you're just beginning or even if you choose not to share your art publicly, you're still an artist.”

OBITUARIES – MEMORY ETERNAL



GREGORY GOLODOFF
APRIL 19, 1939 -
NOVEMBER 17, 2023

On the evening of Nov. 17, 2023, the servant of God, Gregory - Gregor, as his wife so affectionately called him - peacefully left this earthly life. Gregory was born on Attu Island in the Aleutians to his

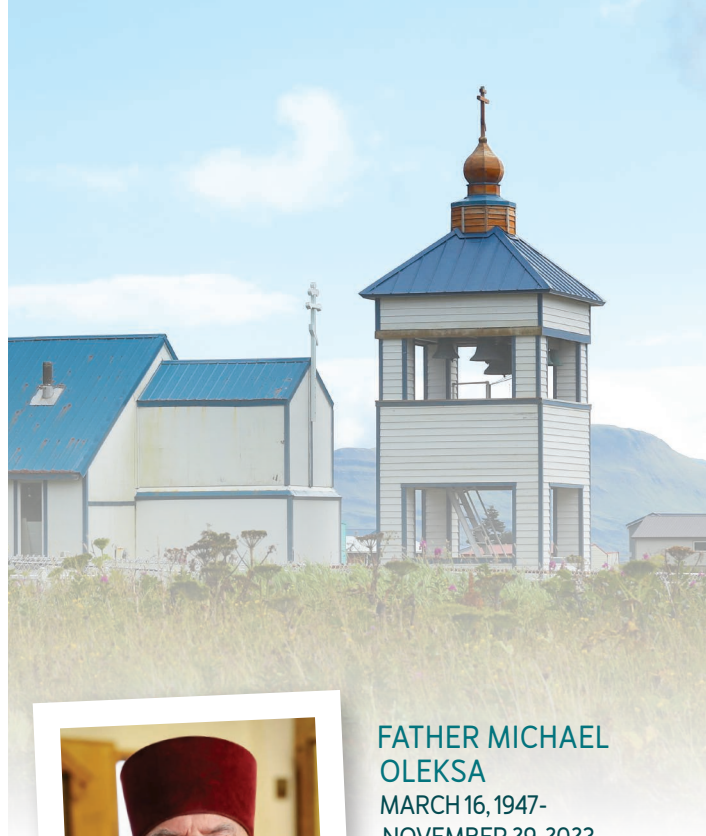
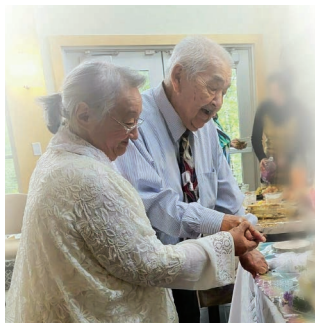
parents, Olean Horosoff Golodoff and Lawrence Golodoff. He was the last surviving prisoner of war, taken at age 3, from his hometown of Attu to Japan during World War II. After the war, the U.S. government brought him, along with his surviving family members, to the village of Atka, Alaska, where he spent most of his life. As a young man, he served his country in the U.S. Army and was stationed in Germany, of which he had fond memories. After he was honorably discharged, he returned to Atka.

During his 84 years of life, he served on many boards and councils in Atka, and served as Tribal President during the time the new subdivision and school were being built in the 1980s. He also served as the local Store Manager with his wife, Pauline, for many years. In addition, he and Pauline commercially fished for halibut together in a skiff that Greg built. He was living in Anchorage, Alaska, with his wife for the last five to six years prior to his passing.

He enjoyed woodworking, taking four-wheeler rides on the beach with his wife, exploring new technologies and gadgets, playing Nintendo video games and his wife's delicious baking. Family members describe him as smart, innovative, patient, and kind. He had a progressive mindset and liked to joke. Once, in his late 70s, someone made mention of him being an elder and he quickly responded, "who said I'm an elder?!"

Gregory is survived by his partner and wife of 49 years, Pauline Golodoff. He is also survived by his siblings, Agnes Thompson, Lawrence Prokopeuff and Teresa Prokopeuff; as well as many cousins, nieces, and nephews.

May his Memory be Eternal.



FATHER MICHAEL OLEKSA
MARCH 16, 1947 -
NOVEMBER 29, 2023

Father Oleksa served as a priest in more than a dozen Alaska Native villages across the state over his five decades in Alaska. He came to Kwethluk in 1972,

where he met his wife Xenia and served as a deacon before spending time as a priest in Napaskiak.

Oleksa was born on March 16, 1947, in Allentown, Pa. He came to Alaska in 1970 from St. Vladimir's Seminary in New York at the invitation of the Alutiiq village of Old Harbor on Kodiak Island.

Oleksa was a leader in cross-cultural communication in Alaska and a student of Alaska Native languages and cultures. He taught at multiple universities in Alaska and published books on Russian Orthodox history, including "Orthodox Alaska" and "Alaskan Missionary Spirituality." He earned his Ph.D. in Slovakia in 1988, with an emphasis on Alaska Native history during the Alaska Russian period from 1741 to 1867.

Oleksa is survived by his wife and children.

We thank Father Oleksa for all the tremendous work he has done for the Unangaġ community – Memory Eternal.



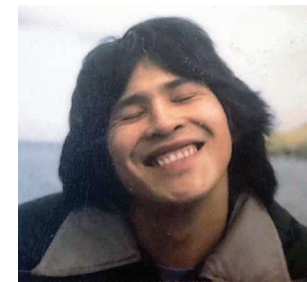
JACOB STEPETIN
NOVEMBER 5, 1952 -
DECEMBER 18, 2023

Jacob Martin Stepetin, aged 71, of Akutan, Alaska, passed away on December 18, 2023.

Jacob was born on November 5, 1952, to Mattie and Art Stepetin in Akutan, Alaska. Jacob was an innovative Unangaġ leader who left a long legacy of progressive change. He inspired everyone who knew him, and he is remembered as a beloved Elder, Unangaġ leader, and culture keeper of Akutan.

Jacob was also known as a gifted community leader, a dedicated Unangaġ advocate, a skilled fisherman, and a loving father, grandfather, brother, uncle, and friend. At only 19 years old, Jacob was the first mayor of the City of Akutan. He worked dutifully and diligently to incorporate Akutan as a City in order to harness benefits, such as the raw fish tax amidst the early heydays of crab fishing in Alaska. Akutan became a superpower in the fishing industry due to the inspired leadership and dedication which Jacob displayed for many years. Jacob was an original board member for the Aleutian Pribilof Islands Association (APIA), the Alaska Native non-profit organization serving the Aleutian and Pribilof Islands Region for health and social services, and he served on numerous boards throughout the Aleutian Region during his lifetime.



Jacob is remembered as a loving father, grandfather, uncle, brother, and great friend to many. He is survived by his three children, Jacob Mark, Robin, and Haliehana Stepetin. Jacob thrived in his role as Grandpa over the last decade to his surviving grandchildren Jordan, Jaxson, James, and his "Chubs," also known as "Tato," Jayce. Jacob is survived by his siblings Anita Pelkey, Vera Pelkey, and Art Stepetin II, and by numerous nieces, nephews, and godchildren. He was preceded in death by his mother, Matriona Stepetin, his father, Arthur Stepetin Sr., his brothers Sam, Peter, and Thomas, and his sisters Anna, Alice, Agnes, Pauline, Nancy, Sophie, Florence, and Jennie.

As a former recipient of the Foundation, I recognize how impactful our programs are for our people.

TAF has been working hard to process scholarship information from our many academic year applicants. Additionally, we received several scholarship applications during our November 30 deadline supporting Winter/Spring applicants. We continue to see students pursuing certification, professional licensures, and more through TAF's vocational training and career development programs.

For descendants who are in grade school or high school – TAF has several youth programs. We offer Youth Advance Scholarships for athletic, scholastic, or artistic activities, Voyage and ANSEP funding, and the Cash for Good Grades program.

Thinking ahead toward summer means culture camps will be taking place. TAF works to support our partners in their hosting of Unangan culture camps with cultural preservation grants. Additionally, we offer travel scholarships to support shareholder/descendant travel to culture camps.

Also, The Aleut Foundation has a new website! Our website was re-designed with feedback from our applicants and Student Advisory Council. Most of our programs are processed using our online application system – you can apply for a user profile anytime!

It is an honor and a privilege to take on this role at the Foundation. I look forward to supporting our shareholders and descendants through educational and cultural opportunities.
