I scheduled my visit to Nikolski to coincide with the 75th Anniversary of the WWII Bombing of Dutch Harbor/Unalaska and the Aleut Evacuation. This memorable commemoration event took place over a three-day period in

## VILLAGE CORPORATION PRESIDENT'S ROUNDTABLE

Each year the Aleut Corporation hosts the annual Village Corporation President's Roundtable. One of the main purposes of the President's Roundtable is to foster positive, two-way communication between the Aleut Corporation and the Village Corporations and learn how we can work together for the betterment of all Aleut people no matter where we live. The President's Roundtable is also a great avenue for Village Corporations to come together to have open dialogue and learn how they can work together as well. This year the meeting took place on April 18th with 12 of the 13 Aleut village corporations participating. Unga Corporation was the only village corporation unable to attend.

President Mack gave an update on Aleut Corporation's current events which included the 2017 Shareholder dividend of \$6/share and a \$550 elder benefit for those who are 60 years or older as of March 31, 2017. This year's 7(j) payment to at-large shareholders and village corporations is \$12.43 per share. He also reported on the possibility of Adak port development and expansion of high speed internet to the Aleutian region. The Aleut Real Estate General Manager, Melvin Smith reported on a variety of mining projects in the region and Cynthia Lind, Executive Director for The Aleut Foundation related important scholarship information and deadline dates. Village representatives presented their community projects and upcoming Culture Camps.

President Mack would like to thank all the Village Corporation's representative who were present for their active participation as we at the Aleut Corporation value the open dialogue that takes place during this important meeting.

## ALASKA TERRITORIAL GUARD



On May 26th I attended the Alaska Territorial Guard (ATG) Honorable Discharge Ceremony of the soldiers who served and protected Alaska during World War II, at the Alaska Native Heritage Center. Of the 16 soldiers, four were from our region: Private Arseny D. Kenezuroff (Belkofski), Private Constantine Lestenkof (St. George), Private George Bourdukofsky (St. Paul), and Private John P. Merculieff (St. Paul). There are two living Territorial Guards in King Cove who have not yet been discharged; Knute Anderson (88) and Herman "Buddy" Bendixen (91). The Office of Veteran Affairs will be honoring Knute and Buddy in person later this year.

## ALEUT REMAINS BURIED ON SHEMA ISLAND

Aleut remains taken from Attu Island during World War II were returned to the Aleut Corporation from the United States Navy along with remains that were recovered by the USF&WS from Rat Island. These remains were repatriated recently to the Aleut Corporation under the Native American Graves Protection and Repatriation Act (NAGPRA).

Karlene Leeper, Cultural Resources Program Manager with the U.S. Air Force 611 Air Support Group and their crew were instrumental in coordinating the trip to Shemya and assisting with the burial.

Pictured and assisting with the burial with Melvin Smith, General Manager of Aleut Real Estate is shareholder Robert Golley from Atka, who is stationed and works on Shemya Island.

The Aleut Corporation has three Historical and Cemetery 14(h) sites on Shemya. The gravesite these remains are laid to rest in holds various Aleut remains from the far western Aleutians and this ensures that the remains will not be disturbed again.

Summer in Alaska means around the clock activity and your board has been very busy these past few months. I am happy to report on our recent directives found in this Newsletter. Recently, I was very honored to represent the Aleut Corporation in Unalaska where I attended the 75th Anniversary of the Bombing of Dutch Harbor and Aleut Evacuation. Unalaska and Dutch Harbor extended warm welcomes to all in attendance and it felt like being at home while at the events of this important anniversary. Of the over 800 Aleuts evacuated during 1942, over 10% were lost having succumbed to various diseases and conditions they were subjected to in Southeast Alaska. As this time does for many, my participation in this event brought to mind my mother, Angelina (Snigaroff) Guenther who was moved with her whole family to Killisnoo from Atka where her community resided until their return in 1945. My mother's earliest memories were not of the village of her birthplace, but of Killisnoo where her family lived through difficult circumstances to get through this challenging time in our history.

Many have similar stories of family members and loved ones and this time in Unalaska and Dutch Harbor was a time of remembrance and healing for all involved. This is a story that must not be forgotten. The stories told, although very painful, must be remembered so that our young people know what our people endured for our future generations. On behalf of your board of directors, I extend a very special thank you to everyone in Unalaska, Dutch Harbor, Anchorage and outlying communities who made this event a moment of healing to all in attendance. I hope we can share more on this event at future meetings.

Hold your phone landscape and take a picture of your friend swaying back and forth like tall grass being swayed by the winds. Take a few pictures and a 10 second video. We want to see you from hands to feet swaying. Ladies - hold your hands away from each other. Guys - turn your hands inward.

## ARS INTERNATIONAL, LLC

ONE OF OUR PROJECTS: An ARS company was awarded an 8(a) sole source contract by U.S. Army MICC to perform the demolition, remediation, and closure of a Groundwater Extractions, Treatment and Injection System. Our work included the demolition and remediation of the groundwater treatment plant, >61,000 LF of pipeline, and the abandonment of 29 wells. Prior to demolishing the treatment plant, ARS collected and treated about 130,000 gallons of potentially contaminated groundwater.

COOL FACTS: ARS is one of a select few small businesses that is licensed by the Nuclear Regulatory Commission to handle highly radioactive contaminated materials (up to 2 Cilisotope). This allows us to work on highly contaminated Federal Government sites.

# ADAK

## ONE OF THE ALEUT CORPORATION'S GREATEST ASSETS

Adak, sitting halfway between the continental United States and Russia where the Bering Sea and Pacific Ocean meet, is ready for new development and international opportunities.

### ADAK: 1940 TO 2015

Over a half century ago, in 1942, the US military recognized Adak's globally strategic location and built the Adak Army Base and Naval Operating Base to assist in World War II operations. Years later, Adak played a key role as a reconnaissance station, keeping tabs on Soviet submarines during the Cold War.

Adak's strategic positioning has made it a 20th and 21st century geographical and geopolitical asset for the United States.

In 1994, the Adak Naval Station was decommissioned; in 2003, the Aleut Corporation exchanged equal lands for the naval station. Besides the land and infrastructure, the transfer created over \$493 million in allowable tax deductions for the corporation. Over the past 10 years TAC has realized \$39 million in tax savings from these tax deductions and will continue to realize many millions more in coming years. These savings translate directly to TAC's profits which determines Shareholder benefits and dividends.

Two of TAC's subsidiary companies work in Adak. Aleut Real Estate (ARE) manages the island's properties and infrastructure. Aleut Enterprise (AE) oversees the Adak Inn, the port and fishery structures, and sells fuel to trawlers, residents, commercial outfits, airlines and utilities. All AE on-island staff are shareholders or descendants.

### ADAK NOW

The Board of Directors recognized the importance of Adak for TAC's future and in 2015 approved 4 major goals or Adak Concentration Areas. Since then, these goals have been the guiding light for TAC management.

#### GOAL 1: MONETIZE TAC'S POLLOCK FISHERY ALLOCATION

Since the pollock allocation was passed by the late Senator Ted Stevens and the US Congress in 2004, our ability to monetize it has been obstructed by multiple challenges. TAC management continue to work with Alaska's congressional delegation, lobbyists, and state representatives to realize our allocation.

#### GOAL 2: CREATE A VIBRANT AND PROFITABLE FISHING AND PROCESSING INDUSTRY IN ADAK

Currently there are two processors operating out of Adak and TAC and its subsidiaries actively research possible markets to support these processors. Their success is ultimately our success.

#### GOAL 3: DEVELOP ADAK AS THE TRANSSHIPMENT PORT AND CONTAINER MEGA PORT

Adak is located in the middle of the Great Pacific Circle Route, which is one of the busiest marine and air corridors in the world. As its strategic location was recognized 75 years ago, Adak's location is again being recognized, this time as a potential shipping hub. The international polar sea routes are rapidly changing and the up-and-coming marine superhighway, the Northern Sea Route, offers time-saving and cost-saving opportunities for worldwide shippers. Adak sits at the intersection of the Great Pacific Circle Route and the Northern Sea Route. Adak also has a deep water port that can be utilized by the largest of ships. It also has an airport and two runways that can accommodate jet aircraft.



#### GOAL 4: MARKET ADAK AS A STRATEGIC LOCATION FOR THE COAST GUARD AND NAVY.

Adak is the United States' westernmost hub in the North Pacific. Its military strategic positioning, deep water ports and active airport can accommodate both deep draft vessels and large aircraft. Coves and harbors sheltered from the predominant winds, and developable land make Adak the most cost efficient and effective means for the US military to gather in the Arctic. If Adak again sees military development it will have come full circle from its beginnings as a US naval base in the 1940s.

### WHY ADAK IS IMPORTANT TO TAC SHAREHOLDERS AND DESCENDANTS

It is important that as a shareholder or descendant of the Aleut Corporation you understand the global importance of Adak. These four goals are attainable. From fishing allocations to international transshipment, they make up a valuable diversified asset for TAC. Each goal has a series of strategies and tactics along with timelines. As a living document, the four goals are continually monitored and evaluated. Your Board of Directors, TAC management and staff are working diligently with Alaska's federal and state representatives, fishery groups, residents of Adak, the international shipping industry, the military and the Arctic Council to make sure that we manage our Adak asset to benefit you.

### 7i REVENUE SHARING

With Congress again taking up legislation that could open the Arctic National Wildlife Refuge ("ANWR") to oil development, many Native Corporations are again discussing the issue of whether revenue from ANWR should be shared under Section 7(i). The Aleut Corporation ("TAC") takes the topic of Section 7(i) revenue sharing very seriously.

Section 7(i) of the Alaska Native Claims Settlement Act ("ANCSA"), enacted by Congress in 1971, requires Regional Corporations to share among themselves, "seventy percent of all revenues received by each Regional Corporation from the timber resources and subsurface estate patented to it pursuant to [ANCSA]." Other sections of ANCSA require that a portion of the amount that each Regional Corporation receives under Section 7(i) be shared with its at-large shareholders and Village Corporations.

If you own at-large shares (which were shares issued to an original TAC shareholder who didn't enroll in a Village Corporation), you receive an additional dividend every year from a portion of the Section 7(i) revenue sharing received by TAC. If you are a TAC shareholder with shares issued to an original shareholder enrolled in a Village Corporation, your Village Corporation receives a portion of the Section 7(i) sharing received each year by TAC. Village Corporations then have the discretion to use those funds as they so choose, including operations, investments, or dividends.

The language of Section 7(i) is so vague that some Regional Corporations, including TAC, had to mount legal challenges to make sure revenues were properly being shared by other Regional Corporations under Section 7(i). Eventually, in 1982 the leadership from all twelve regions agreed to a settlement aimed at resolving disputes on how to calculate the amount of revenue to be shared under Section 7(i). Known as the Section 7(i) Settlement Agreement, the settlement was approved by the board of each of the twelve Regional Corporations. One section of the Section 7(i) Settlement Agreement says if surface estate is exchanged for subsurface estate, revenue from the subsurface estate received in the exchange does not have to be shared.

In 1983, the Arctic Slope Regional Corporation ("ASRC") entered into a land exchange agreement with the U.S.

Department of Interior, exchanging land in Gates of the Arctic National Park for subsurface estate in ANWR. The agreement prohibited production of oil and gas, or development leading to production, on the lands acquired by ASRC until Congress opened ANWR to oil production.

After the other Regional Corporations learned of the ASRC/ANWR land exchange in 1985, three of them, including TAC, brought a legal claim to require ASRC to share any revenue it receives from its lands in ANWR with the other Regional Corporations under Section 7(i). The claims were brought in arbitration as required under the Section 7(i) Settlement Agreement. In 1989, the arbitration panel ruled that the land exchange was a straight surface-for-subsurface land exchange and that under the Section 7(i) Settlement Agreement ASRC did not have to share revenue it receives from its land in ANWR with the other Regional Corporations. The decision is binding on all Regional Corporations, regardless of whether they participated as parties in the arbitration.

If Congress votes to open ANWR to oil development now, ASRC will be able to develop its land in ANWR for oil and gas and, under the 1989 arbitration decision, it will not be required to share any revenue it receives from its lands in ANWR with the other Regional Corporations under Section 7(i).

Since the arbitration decision came down in 1989, individual shareholders of other Regional Corporations have twice brought legal actions to force sharing of ASRC's ANWR revenues – without success. To date the courts have also refused to allow Village Corporations to force Regional Corporations to share revenue under Section 7(i). With Congress again taking up the issue of opening ANWR, some Regional Corporations and Village Corporations are renewing the claim that the revenue ASRC receives from ANWR should be subject to sharing under Section 7(i). The claim presents numerous legal and political challenges that the TAC Board and Management continue to track closely and maintain open communications on with all of the other Regional Corporations.

The Aleut Corporation Board and Management are committed to proceeding in a way that best protects the interests of all TAC shareholders.

We will continue to monitor this situation and provide updates as the situation develops.
