# LETTER FROM THE PRESIDENT

Aang Unangax Family,

It was so good to be back in our region visiting with shareholders and descendants. A few weeks ago, The Aleut

Corporation staff and a small film crew landed in Unalaska, where we kicked off our first leg of a multi-day tour, visiting Unalaska, Nikolski, and Akutan. Unfortunately, we were not able to stop in Atka due to weather.

On my first morning in Unalaska, the Museum of the Aleutians Executive Director Virginia Hatfield gave us a behind-thescenes tour. I was stunned to see an exhibit on hunting spears, featuring work and quotes from my grandfather William Tcheripanoff. You can see the care and attention that goes into each exhibit.

Afterwards, I had the chance to sit down with the Ounalashka Corporation (OC) and their Board of Directors to discuss how TAC and OC can better partner for the future. Then, we visited the Qawalangin Tribe before our shareholder meeting. Turnout for the meeting was great, with well over 50 shareholders and descendants in attendance.

The next day, we landed in Nikolski. What an amazing community on the edge of stunning Umnak Island! We met with our shareholders and descendants in the community center and visited the APICDA lodge, the church, and an incredible



community greenhouse. Unfortunately, weather prevented us from staying the night and our time was cut short. The community of Nikolski was a very gracious and wonderful host.

My mother, Sarah Tcheripanoff Virg-In, joined us in Akutan, the town where she grew up. I met family for the first time and hugged others I hadn't seen since I was a kid. Akutan welcomed us with a community potluck after our shareholder meeting. The food was fantastic! We were privileged to spend the day with Josephine Shangin, President of the Akutan Corporation, while she taught kids how to braid seal intestine. And with Hugh Pelkey, a talented Unangan artist, who shared with us the skills he learned under my grandfather.

We have an important update to announce regarding our 50th Annual Meeting of Shareholders. On the recommendation of TAC Management, the Board of Directors has voted to move this year's meeting from October 15 to November 12, 2022. This change is due to Aleut Federal's portion of the annual audit taking longer than anticipated.

Aleut Federal is our largest subsidiary with approximately 800 employees. Focused primarily on government contracting, they are responsible for 80% of our revenue and operating income. This past year has been one of stabilization for Aleut Federal. In response to their financial challenges in Fiscal Year 21, the Board moved quickly to bring in new TAC leadership, oversee the restructuring of Aleut Federal's operations, support the implementation of a new financial management system, and hire new auditors. These changes were necessary last year to secure Aleut Federal's foundation for growth.

I cannot say enough how grateful and honored I am to be able to serve you and I am truly sorry for any impact this date change may have on your travel plans. We look forward to seeing you either for an upcoming community visit in August, or on November 12 for the 50th Annual Meeting of Shareholders. Enter your email address for a confirmation that you submitted your proxy through the internet.

Click "Vote" and exit the system.





VIETNAM VETERAN Land Allotment

In 1971, the Alaska Native Claims Settlement Act (ANCSA) repealed the Alaska Native Allotment Act, which allowed eligible Alaska Natives to apply for land allotments. Alaska Natives who served in the military during the Vietnamera may have missed their opportunity to apply. In 2019, The Department of Interior (DOI) reopened this program and extended the deadline to apply until 2025.

The Alaska Native Veteran Land Allotment Program is open to all eligible Alaska Natives who served in the military between Aug. 5, 1964, and Dec. 31, 1971. If eligible, Alaska Native veterans may select up to 160 acres of federal land.

Recently, the DOI announced it is releasing an additional 27 million acres of federal land from which eligible Alaska Native Vietnam Veterans may select allotments. The new land descriptions and maps are expected to be published late September or October 2022.

For King Cove's Rose Pletnikoff, her jewelry side business is a labor of love. At Kda $\hat{x}$  by Rose, she sells custom-designed earrings that are inspired by the bentwood visor she created at culture camp.

"It's a very unique design," she said of the visor. "I incorporate fish-skin leather and beads into my pieces. I've tried hard to make my art meaningful and connected to our people and culture, and using that unique design is just one of the ways I'm able to do that."

Rose said her jewelry design and enjoyment of other art comes from her Unanga<sup>2</sup> culture and growing up in King Cove. She started oil painting when she was in high school, taking cues from Bob Ross on television and using her dad's old paint supplies. Her grandmother taught her how to sew, and even helped her make her first quilt. It's a skill that has stayed with her over the years – since that quilt, she's always had a sewing machine.

During quarantine, Rose took up oil painting again and also started sewing masks. At the time, she was living in Kodiak, a the island community faced a major mask shortage.

"It was great to help people out in that way," she said, reflecti on the months in 2020 spent making countless cloth masks during the COVID-19 pandemic. "I started sewing headbands

after making the masks, and even dabbled in beadwork, which is how I came to start creating earrings."

Rose credits a couple of artist friends who saw her beadwork with giving her the idea for her business. They encouraged her to keep practicing her beadwork and suggested she consider selling it. Her business took flight from there.

Art is nothing without inspiration, and Rose draws her inspiration from her culture.

"Right before the pandemic started, I was working at the Alutiiq Museum in Kodiak, and seeing all of the cultural artifacts and fabrics and designs and history up close and personal every day was incredible," she recalled. "I really believe it's important to get our Unanga<sup>2</sup> culture and heritage out there for people to see and understand. That representation really matters, and I'm glad I can contribute to it."

In addition to growing up in King Cove and going to culture camps, Rose has also been a part of the Aleut Dancers group that has performed multiple times at AFN. All of that cultural connection has been deeply meaningful, helping inform her identity and art, and the continuing evolution of both.

"My art and earring designs are a real outlet for me – it's personally fulfilling and satisfying to do something like this," she said. "I hope my artwork serves as an inspiration for other up-and-coming artists to get creative, and take up healthy activities!"
